## The minutes of the meeting held on Tuesday 14th June have been reviewed and no amendments were needed.

It was lovely to welcome several new attendees to the meeting today including a new parent and our new NDCS local engagement officer. We had also hoped to welcome the East Berkshire paediatrician who is now leading on hearing loss but unfortunately he was called away just before the meeting.

There have been a number of changes within the health visitor team and currently we do not have any representatives from that department.

## <u>Feedback of progress and next steps from the breakout groups in the June meeting.</u>

## 1. <u>Hearing the Deaf CYP and families voice - review of survey questions and timeline of use</u>

Discussion

- It is appreciated that all services conduct surveys across the year but it is also important that we can collect the parent / student voices.
- Alison Skinner has designed two surveys a primary and a secondary version
- 3 schools have fed back on the survey at this point.
- There may have been some mis-communication about the survey
- An electronic method of completing the survey was felt to be a good way forward although depending on the format this may make it more challenging to complete if there are several children in one setting
- We need to ensure that the questions on the survey help to identify areas that we can focus on to improve the experiences of deaf CYP
- Jane Peters highlighted that Berkshire Sensory Consortium Service sends out an annual survey that goes to all schools, parents and children supported by the service. There is a preschool and school age version. We all send out surveys following events.
- Perhaps a link to the survey on reports from different services may work.
- We need to agree how long the survey will run for and when this is likely to go out.
- Thanks were expressed to Alison Skinner for getting the work started with the survey formats.
- How could we reach the older CYP directly if they are able to complete the survey on their own.

#### **Agreed Actions**

- Gail to email CHSWG group to ask for volunteers for this working group and to arrange a member of the BSCS team to attend.
- Creation of a separate working group to take this forward with a maximum of 8 people to include Alison Skinner, representatives from audiology, BSCS and other key services.
- Working group membership to be agreed within the next 4 weeks and date for first meeting arranged.

## 2. <u>School Nurse Screening - update from meeting with school nurse team</u> Feedback

- Access to screening different across Berkshire
- W. Berks / Bracknell screening offered to every school entrant
- Reading / Wokingham questionnaire to opt in to school hearing screening
- RBWM Offered to all but only taken up where there are concerns
- Slough Everyone tested and this is leading to a high level of referrals and a high DNA rate for Audiology appointments. This is being looked into as it is felt there may be issues around test conditions.
- Alison Skinner raised concerns about the possibility of children slipping through the net if not offered to all. Suggestion made to explore further with NDCS to establish the national picture. Hannah Brown is happy to discuss further outside of the meeting.
- Abby Martin, Julia Lamming and Karen Jacobs have met with RBH to look at the questionnaire being used and to make adjustments to the wording, e.g. working in conjunction with Louise Dix to to add in questions about speech and language development.
- Looking at sending out a newsletter to the whole of Berkshire relating to Speech and Language Therapy and hearing. It is hoped this will help with improving the questionnaire and referral rates where needed. It may be possible to extend this to RBWM.
- The letter to health was also discussed. This requires a medical lead and liaison with Hannah Brown.

#### **Parental Feedback**

Alison Skinner reported that there was no new feedback from parents but feels that it would be good to revisit feedback from the last few meetings to ensure that there were no outstanding actions. One such area is the use of positive language.

Jane Peters fed back that BSCS has reviewed its use of terminology and made changes and a statement on this is due to be added to the website. This has also been flagged with Local Authorities but they are required to follow the lead from the Department for Education.

Alison also raised the issue around access for deaf children and young people to have full access to mainstream clubs and activities.

Alison Skinner thanked the BDCS committee for their work in organising different events for families.

Emma Conquer, who joined us for the first time this meeting, felt that it had been very interesting and informative and have been pleased with the services they have received since diagnosis.

#### **BDCS Feedback**

A number of events have taken place. Feedback from children who have had the opportunity to meet other deaf children, perhaps for the first time, has been very positive.

Katie Ireland reported that they often get to hear about the events from families when they visit audiology.

There are a number of events coming up including a driving event for 10 - 18 year olds, 2 trips to pantomimes (Reading and London), ice skating and a Christmas party. BDCS are trying to target a wide range of ages but appreciate there is not as much aimed at babies.

Swimming lessons were discussed. The pool and instructor previously used are no longer an option but if there is a demand they can explore this. Alternatives were discussed including Disability Swimming at Braywick where there is 1:1 instruction. Emma Conquer reported that Hydrokidz swimming classes had been successful.

#### **Professionals Feedback**

#### **Berkshire Sensory Consortium Service**

- We are currently fully staffed. We have one ToD in training and our new QToD joined us in September.
- We have had a comparatively high number of new referrals so far this academic year. Referrals from audiology departments beyond our two main hospitals seem to be coming through more smoothly and we continue to work on building these links.
- Berkshire Sensory Consortium Service celebrates 25 years of the joint Local Authority arrangement this year.
- Jane ran 2 parental information sessions (one morning and one evening) about how our service works and our packages of support. The feedback was positive. We are looking to run additional sessions next term.

### Multiprofessional support focus

- 1. Joint working with SLT on joint reporting.
- 2. Joint working with Health Visitors around the 2 year old checks where we are involved.

#### **Speech and Language Therapy**

- BHFT Guidance is back to wearing Masks for home visits- we have a good supply of clear masks, 2 different sorts.
- Recently for some Education, Health and Care Plan requests, the most recent speech and language therapy advice has not been included into draft Planinformation has been drawn from a previous plan. The LA involved is keen to put this right when contacted, but we are working to understand why this has happened and to avoid this.
- The CYPIT Mainstream SLT Team continues to run training for mainstream school staff online, staff from Hearing Resource Bases have attended and feedback has been positive. They plan to run one around the potential impact of glue ear on speech and language and are liaising with Louise Dix about it.

#### **University of Southampton Auditory Implant Service**

- Clinic capacity back to normal. Making good progress in seeing patients whose reviews were delayed/postponed during 2020-21.
- Currently still encouraging face masks and social distancing in the waiting area but optional in the clinic rooms. Any masks worn by staff are either clear or have clear panels.
- Recruiting another SaLT. Interviews 16/11/22.
- BCHI surgical offer is expanding for adults will now include MEI (middle ear implants), Bonebridge and Osia for those meeting candidacy criteria. To be considered for older teens on a case by case basis. Suitability for younger CYP to be considered at a later stage.

#### **Royal Berkshire Hospital - Audiology**

- Audiology has been exceptionally busy recently with unprecedented pressure on services due to increased numbers of NHSP screening and increased number of births. However all babies have been seen within the 4 week target.
- Recruitment is taking place for a new NHSP manager as the previous one left in August.
- NHSP team have faced challenges and there is currently a backlog. One person is currently being trained.
- Ani is working on the transition day to take place at Mary Hare school later in the year. The date is to be confirmed and they are hoping the NDCS roadshow bus will be able to attend.

#### **NDCS**

- CHSWG updates have been sent with these minutes
- The applications for Family Sign Language Courses open on the 21st November 2022.

#### NHSP - Wexham Park

- NHSP screening continues as before
- There has been an influx of referrals sent on to audiology
- Val announced she will be retiring but a successor has been lined up in preparation for a seamless transition.
- Val thanked everyone for the support and work over the years she has been in post.

#### **Guys and St Thomas Implant Centre**

- The service is currently working with a blended service model
- A range of groups are offered including for transition between paediatric and adult services.

- Training for ABI is available and there is also an online support group
- The BEARs (Both EARs) project will be moving out nationally in January.

- Katie and Gail, Co-chairs of the Pan Berkshire CHSWG group request that any members interested in taking on the role of chair going forwards make contact. The role of chair is to be passed on every couple of years and any member of the CHSWG can take on this role.
